### BEFORE SIGNING, PLEASE READ THE FOLLOWING:

If my/our application is approved for membership in the NEW YORK RUG CLEANERS INSTITUTE, INC., It is understood by me and my associates that the following is understood and agreed to:

**USE OF EMBLEM:** Upon election to membership each member shall be entitled to use the official emblem of the institute in any form provided by the Institute as long as the firm remains in good standing. Upon withdrawal from membership, for any reason whatsoever, former members must remove all evidence of membership, either by words or emblem, from any premises, stationary, advertising devices and vehicles in use at a firm.

**PURCHASE AND SALE OF MEMBER BUSINESS:** A membership held in a corporate name shall not be affected by change of ownership of that corporation. Where a membership is held in a partnership a change in ownership of 50% or more shall require a new member application and approval by the Board of Directors in order for the newly constituted partnership to be a member of the Institute. The purchaser of a proprietorship does not by virtue of such purchases become a member of the Institute but must submit a membership application to the Board of Directors. Sale of a business interest shall not terminate the membership obligations of the seller.

**RESIGNATION, WITHDRAWALS, ETC.:** The membership of any member of this organization is conditioned upon each member complying with all of the rules, regulations and conditions of the organization including payments of dues, assessments, liabilities, and all obligations. No member may withdraw for any reason, whether by discontinuance of his business or otherwise without first settling all obligations and assessments of the Institute. Registrations must be sent to the office of the Institute in writing.

**BY-LAWS:** I AGREE TO ABIDE BY THE BY LAWS OF N.Y.R.C.I.

**DUES AND ASSESSMENTS:** Members of this Institute shall pay dues and assessments as are fixed by the Board of Directors.
